

DIRSIG™ Alliance Membership Agreement

This Membership Agreement (“Agreement”) is entered into by and between _____ (“Member”) and the Rochester Institute of Technology (“RIT”), a New York State not-for-profit educational corporation. This Agreement outlines the terms under which the Member will participate in the DIRSIG Alliance, a network of member entities supporting the advancement and maintenance of the Digital Imaging and Remote Sensing Image Generation (DIRSIG) software ecosystem.

The DIRSIG Alliance provides an organized framework for sustaining DIRSIG ’s technical development, user engagement, and platform reliability. The Alliance is supported by membership dues that directly support the RIT DIRSIG team and DIRSIG activities such as software enhancements, documentation, training materials, and community support.

RIT anticipates the baseline DIRSIG ecosystem will continue to be made available, free-of-charge, to any eligible individual who completes the DIRSIG training (including those who are not a member of the Alliance). However, this free version of DIRSIG (referred to as the **Cornerstone Edition**) will only be released on an annual basis and will only include minimal updates.

The DIRSIG **Alliance Edition** is only available to active Alliance members and is where all newly developed features will appear going forward. DIRSIG Alliance members will also have exclusive access to participation in Member meetings and communications, new releases/versions, and extensive value-added services by the DIRSIG team. Members will have the opportunity to test new versions and features of DIRSIG , but most importantly they will have access to features and support services not available to DIRSIG **Cornerstone Edition** users.

The complete details of Member-exclusive benefits and software edition features are described in Tables 1 and 2.

¹ Free, in-person training for *Partner* members is limited to 4 attendees per Partner per year and is subject to seat availability in a given session. Once available, access to asynchronous training is unlimited for all Alliance membership tiers.

² “New Features” refers to an expansion of the feature set of the DIRSIG software. In general, only the **Alliance Edition** will receive new features and the **Cornerstone Edition** will not. However, the DIRSIG Team reserves the right to integrate any newly developed feature into the **Cornerstone Edition** to maintain software stability.

³ “Derived Products” refer to data produced by the model and derived products including data and algorithms trained on data produced by the model. These products can be distributed free of charge at any membership level. However, to charge for derived products, the user and/or organization must be at the *Support Partner* level or higher.

⁴ “Plugin Development” includes access to the DIRSIG Software Developer Kit (SDK) and the ability to develop native run-time software plugins that extend the capabilities of the software. Active membership at the *Development Partner* level or greater is required for plugins to continue to be recognized by the DIRSIG software.

⁵ “Software Integration” includes integrating the DIRSIG software into a software platform that is accessed by untrained DIRSIG users for free or at a cost. Active membership at the *Integration Partner* level or greater is required for integrations of the DIRSIG software to continue to be offered.

⁶ Members in the *Leadership Partner* tier will have a seat on the DIRSIG Alliance Board of Advisors. Board members will participate in discussions that shape future DIRSIG ecosystem development in an advisory fashion.

Rights and permissions discussed here are superseded by explicit definitions defined in the EULA.

Members in the *Integration Partner* and *Development Partner* tiers *must maintain* these annual membership levels (or a higher level) to continue to offer and/or use their integrated products or plugins.

Membership benefits are subject to reasonable change over time as the DIRSIG Alliance grows and evolves. RIT will notify Members of any such updates in advance.

Legacy and New User Support

Any users that attended DIRSIG training in 2025 and beyond will be automatically enrolled in the Alliance *Individual* tier for 1 year. At the end of that year, the user can choose to enroll in the *Individual* or any Alliance Partner tier. If they choose not to join the Alliance, they will retain access to the DIRSIG **Cornerstone Edition**, which *does not* include features available in the **Alliance Edition**.

Sponsored Research Credit

Any Alliance member who enters into one or more sponsored research agreements with the DIRSIG team, administered by Rochester Institute of Technology, resulting in aggregate sponsored research expenditures exceeding one hundred fifty thousand U.S. dollars (150,000 USD) during a single membership year, shall be eligible to receive one (1) annual membership credit in the amount of fifty thousand U.S. dollars (50,000 USD), provided the member enrolls in a *Support Partner*, *Development Partner*, *Integration Partner*, or *Leadership Partner* membership tier for the subsequent membership year.

This credit shall be applied toward the cost of the organization's subsequent annual Alliance membership period.

For clarity, eligibility shall be determined based on actual expenditures posted within the applicable membership year, not on total award value or obligated funding.

Member agrees to:

- Pay annual membership dues within 30 days of invoice receipt, each year of the Agreement term to maintain services described above.
- Assign a contact person to serve as the Member's primary point of contact for DIRSIG Alliance engagement (required for *Integration Partner* and *Leadership Partner* tiers).

RIT agrees to provide:

- Dedicated developers to ensure continuous DIRSIG progress and timely software updates.
- Quarterly or weekly builds (tier dependent) to test and use software enhancements, automatic testing, and enhanced reliability of DIRSIG for professional use.
- Maintenance of the DIRSIG website, documentation, benchmarking, and discussion forums.
- Limited access to in-person training sessions when offered (limit 4 attendees per Partner per year, subject to seat availability) [Partner is responsible for any expenses required to attend in-person training].
- Unlimited access to asynchronous basic and advanced training for all Member employees (once available).
- Monthly DIRSIG Alliance meetings (virtual) to discuss ongoing activities, future directions,

development priorities, and member Q&A.

- An annual DIRSIG User’s Conference for peer exchange and community development.
- A yearly report outlining Alliance activities, plans, and road maps.
- A DIRSIG Developer Liaison (for *Integration Partner* level members and above) for technical communication and engagement (up to 100 hours annually).
- A dedicated Product Manager (for *Leadership Partner* level members) for organization-specific priorities (up to 100 hours annually).

Term and Termination

The Term of this Membership Agreement will commence on the date of the last signature below and renew annually upon payment of dues in effect at the time of renewal.

Either Party may terminate this Agreement without cause with thirty (30) days prior written notice. If terminated by RIT, Member shall receive a prorated refund of their annual fee for the current year. If terminated by Member, no refunds will be issued.

All rights and services associated with the Member’s tier will be revoked at the time of membership termination (or downgraded if membership tier is reduced).

Ownership

RIT retains all rights, title and interest, including all copyright and intellectual property rights, in and to, the DIRSIG software, including without limitation all enhancements, improvements, bug fixes, updates, upgrades, modifications and derivative works thereof, and RIT reserves the sole right to develop, enhance, or otherwise modify the DIRSIG software. All rights not specifically granted in this Agreement are reserved by RIT.

Members may, from time to time, provide RIT with suggestions, enhancement requests, techniques, know-how, comments, feedback or other input with respect to the DIRSIG software (collectively, “Suggestions”). Unless otherwise agreed to in writing by the parties with respect to any Suggestion, and to the fullest extent permitted by law, Member hereby assigns to RIT on both Member and Member’s users behalf, all right, title, and interest in, the Member’s Suggestions; and RIT is free to use, without any attribution or compensation to any party, any ideas, know-how, concepts, techniques, or other intellectual property rights contained in the Suggestions, for any purpose whatsoever, including but not limited to, incorporating into the DIRSIG software, RIT’s services, product, technology, enhancement, documentation or other developments related to the software. Notwithstanding the foregoing, RIT is not required to use any Member Suggestion or portion thereof.

Limitation of Liability and Disclaimer of Warranties

RIT shall not be liable for any indirect, special, incidental, consequential, punitive, or other damage, loss or expense incurred or suffered by Member or any third party regardless of the nature of the claim therefore and even if advised of the possibility of such loss or damage. RIT’s maximum

liability to Member related to this Agreement shall not exceed the amounts paid by Member under this Agreement during the twelve (12) months preceding any such claim.

TO THE FULLEST EXTENT PERMITTED BY LAW, AND EXCEPT AS EXPRESSLY STATED HEREIN, RIT MAKES NO WARRANTY, EXPRESS, IMPLIED, STATUTORY, OR OTHERWISE, AS TO ANY MATTER WHATSOEVER, INCLUDING, WITHOUT LIMITATION, NON-INFRINGEMENT; FITNESS FOR A PARTICULAR PURPOSE; MERCHANTABILITY; OR DESIGN, USE, ORIGINALITY, OR ACCURACY OF THE PROJECT IP, WHETHER TANGIBLE OR INTANGIBLE, CONCEIVED, DISCOVERED, OR DEVELOPED UNDER OR IN CONNECTION WITH THIS AGREEMENT. NOTHING HEREIN SHALL CONSTITUTE ANY REPRESENTATION OR WARRANTY WITH RESPECT TO THE LEVEL OF SERVICE(S) TO BE PROVIDED, NOR SHALL IT BE DEEMED TO CONSTITUTE A SERVICE LEVEL AGREEMENT (SLA) FOR DIRSIG SOFTWARE SUPPORT.

Miscellaneous

Non-Gift Status: Member acknowledges that this Agreement is a fee-for-membership arrangement and does not constitute a charitable contribution. No tax-deductible gift receipt will be issued in connection with this membership.

Export Control and Embargoed Countries: Alliance membership and access to DIRSIG is subject to all applicable export control laws and regulations, including but not limited to EAR, ITAR, OFAC, and limitations on specially designated nationals. RIT reserves the rights to deny and/or modify any Member's participation in accordance with its policies and applicable law. Member warrants they are not organized or resident in a country or territory that is subject to U.S., EU, or United Nations comprehensive trade sanctions (*e.g.*, Crimea, Cuba, North Korea, Iran, and Syria, as such list may be amended). Member further warrant that it is not the target of any trade sanctions administered or enforced by the U.S. Government, the EU, the United Nations, or other applicable governmental authority and are not acting on behalf of any target of trade sanctions.

Assignment: Neither party shall assign its rights or duties under this Agreement without the prior express written consent of the other party; provided, however, that Member may assign this Agreement to a successor in ownership of all or substantially all its business assets who expressly in writing assumes Member's obligations hereunder.

Entire Agreement; Amendment: This document represents the entire understanding between the Parties with respect to membership in the DIRSIG Alliance and may only be amended in writing signed by both Member and an authorized RIT representative. All other terms and conditions, including those related to the DIRSIG software, including the DIRSIG End User License Agreement shall remain in full force and effect as applicable.

Counterparts; Electronic Signature: This Agreement may be executed in counterparts, and electronic formats (*e.g.* PDF or JPG) are valid and enforceable.

Force Majeure; Governing Law: Neither Party shall be held liable for delays or failures beyond its control. This Agreement shall be governed by the laws of the State of New York without regard to its conflicts of law provisions. Any action to enforce this Agreement must be brought in a court situated in, and the parties hereby consent to the jurisdiction of courts situated in Monroe County,

New York. Each Party hereby waives the right to claim that any such court is an inconvenient forum for the resolution of such action.
